



**MEMORANDUM OF UNDERSTANDING
BETWEEN
SUAN SUNANDHA RAJABHAT UNIVERSITY, THAILAND
AND
CHINESE CULTURE UNIVERSITY, TAIWAN**



This Memorandum of Understanding (MOU) is made between Suan Sunandha Rajabhat University, located at 1 U-Thongnok Road, Dusit Sub-district, Bangkok District, Thailand (after herewith "SSRU") and Chinese Culture University, located at 55 Hwa-Kang Road, Shilin District, Taipei City, Taiwan 11114, R. O. C. (after herewith "CCU"),

STATUS OF THIS MEMORANDUM OF UNDERSTANDING

1. This document is not intended to be legally binding.
2. This document is the basis for the preparation of formal contracts or agreements between the parties. For the purpose of implementing each specific contract or agreement activity, both institutions shall prepare the necessary documentation which shall be the object of a Specific Agreement/Contract, to be executed by the concerned parties.
3. The parties do not intend to enter into any legal relationship unless and until such formal contracts or agreements are executed.

OBJECTIVES

1. CCU and SSRU shall work together to expand cooperation and the exchange of ideas in areas of mutual interest.
2. CCU and SSRU shall carry out programs and activities in cooperation with each other.
3. CCU and SSRU shall undertake programs in the areas of:
 - (a) exchange of academic personnel and researchers;
 - (b) joint development of research projects;
 - (c) joint organization of scientific and cultural events;
 - (d) joint teaching and learning management
 - (e) dual degrees

DURATION, AMENDMENTS AND TERMINATION

1. This MOU shall become effective on the date this document is executed by the parties and shall remain in force for a period of three (3) years.
2. Upon the completion of this term, the MOU may be revised, upon the assent of both institutions, and such renewal shall take the form of a new MOU or of a specific Agreement or Contract.
3. Either party can at any time terminate the MOU by the giving of 90 days written notice.
4. This MOU can be varied or amended by mutual consent of the parties, in writing, and such variation or amendment shall become part of this MOU upon the giving of that consent.

RELATIONSHIP BETWEEN THE PARTIES

Nothing contained in this document shall be construed as constituting a joint venture, partnership or formal business arrangement of any kind between the parties or of appointing either party as an agent of the other.
